About Calusa Waterkeeper

Calusa Waterkeeper (CWK) is a non-profit grassroots organization committed to protecting and restoring the Caloosahatchee River from Lake Okeechobee to the Gulf and its surrounding watersheds. CWK works to reduce pollution, restore the health of our waters, and advocate for strong environmental policies. Our mission is driven by science, research, education, and community engagement. Join us in ensuring clean, healthy, and abundant water for all.

Position Summary

We are seeking a passionate, dedicated, and inspiring **Waterkeeper** to join our team. This fulltime, salaried position plays a critical role in protecting and advocating for the 1,000 square miles of waterways within our work area. As the voice and face of CWK's science, research, advocacy, education, and litigation efforts, the Waterkeeper will serve as the lead on water quality monitoring, pollution mitigation, community engagement, and advocacy for clean water. This is an exciting opportunity for a leader with a deep commitment to environmental protection and the health of our waterways.

Key Responsibilities

1. Field Work & Science

- **Watershed Monitoring:** Regularly patrol the Caloosahatchee River and its tributaries via land, air, and water to monitor water quality, pollution sources, and ecosystem health.
- Water Testing: Conduct and manage monthly water quality testing at various locations in the watershed, collect and analyze surface water samples, and ensure adherence to Standard Operating Procedures.
- **Pollution Response:** Investigate pollution complaints, document findings, contact authorities, and assist the public in addressing concerns.
- **Data Management:** Maintain accurate field data for advocacy, legal actions, and scientific research purposes.

- **Cleanup Coordination:** Lead litter removal efforts and assist with site selection, cataloging results, and community engagement in cleanup events.
- **Asset Management:** Oversee the maintenance of CWK assets, including boats, vehicles, and scientific equipment, ensuring they are properly serviced and maintained within budget.
- **Inventory & Purchasing:** Tracks, manages, budgets and places purchase orders for equipment and supplies necessary for monthly water and air testing

2. Advocacy & Policy

- **Pollution Monitoring & Enforcement:** Monitor permitted discharges from Lake O and other sources, ensuring compliance with regulations. Advocate for enforcement actions when violations are detected.
- **Stakeholder Engagement:** Work closely with citizens, local businesses, governmental agencies, and partner organizations to advocate for pollution reduction and watershed protection.
- **Policy Advocacy:** Write comment letters, attend public hearings, and speak at governmental meetings to support policies that protect clean water and environmental health.
- **Public Engagement:** Work to raise awareness of local environmental issues through media outreach, community events, and direct engagement with local decision-makers.

3. Education, Outreach & Media Relations

- **Content Development:** Work with internal or external marketing team to develop educational materials and outreach content in various formats (presentations, social media, press releases, newsletters, blogs) to inform the public on water quality issues and solutions.
- **Public Speaking:** Deliver presentations at community meetings, conferences, and events to educate the public on water conservation, pollution prevention, and CWK's mission.
- **Media Engagement:** Act as the primary spokesperson for CWK, responding to media inquiries, conducting interviews, and advocating for environmental issues in local and regional media outlets.
- **Community Partnerships:** Build and maintain relationships with stakeholders, including local governments, universities, businesses, and community organizations, to support water quality initiatives.

4. Ranger Program Leadership

- **Ranger Program Oversight:** Manage and grow CWK's ranger program, including recruitment, training, and retention of volunteers.
- **Community Outreach:** Lead educational and outreach programs, such as the Vertical Oyster Garden and Seagrass initiatives, and collaborate on water conservation efforts.

• Science & Education: Ensure high standards for water and air quality testing, manage the CWK science lab, and maintain its equipment.
